2023 Leader on the Rise Delanté Spencer Thomas

Students in the CSU|LAW Civil Litigation Clinic recently presented an oral argument before the Ohio Ninth District Court of Appeals. The case is an appeal of an unemployment compensation decision denying benefits to the Clinic's client.

Lauri Hartmann (*pictured*), a certified Legal Intern supervised by **Professor Emeritus Kenneth Kowalski**, very ably and forcefully presented the argument to a panel of three judges. **Shannon Ferry**, who sat second chair for the argument, along with Clinic students **Zoe Sapp** and **Nick Elrad**, had helped Lauri prepare for the argument with moot court questions and discussions. In addition, students from **Professor Doron Kalir's** Appellate Practice Clinic participated in a practice session, bringing fresh perspectives to the case.
