

### CMLAA holds successful Annual Recognition Luncheon



The Cleveland-Marshall Law Alumni Association (CMLAA) held one of its most successful Annual Recognition Luncheons (ARL) on Thursday, May 23 at the Renaissance Cleveland Downtown Hotel. The 2019 ARL drew almost 1,000 people and grossed almost \$110,000. All net proceeds from this event will go toward funding student scholarships.

The event opened with **Ashley Nemeh**, a C|M|LAW 2L and professional singer, giving a moving

performance of "America the Beautiful". Both Honorees, **Teresa Metcalf Beasley** '92, Member, McDonald Hopkins, and **Judge John J. Russo** '92, Administrative and Presiding Judge of the Cuyahoga County Common Pleas Court, extolled the virtues of C|M|LAW and told of the debt that they owed the law school. Both also gave emotional remarks about the importance of faith, family, and friends in their lives. They were introduced by, respectively, U.S. District Court **Judge Solomon Oliver**, **Jr.** and Ohio Supreme Court **Justice Michael P. Donnelly** '92.
